Course Description

The emergence and rapid development of the international human rights framework over the last 75 years is a remarkable innovation, yet it is nonetheless evident that human rights abuses continue to impact people around the world. What role do international courts play in our understanding and enjoyment of human rights?

In this seminar, we will discuss the modern system of international human rights protection, its history, its various components, its successes, and its shortcomings. Using primary legal texts and case decisions, as well as textbook excerpts and scholarly critiques, we will examine which rights are considered fundamental and how the interpretation of those rights has expanded over time. We will compare the courts and quasi-judicial bodies that protect human rights, including their jurisdiction, competencies, and impact. Finally, we will discuss the roles and strategies of the various actors involved, including grassroots activists and elected judges.

Students will gain a foundational understanding of international human rights law, essential principles and phases of human rights oversight and dispute resolution, and current critiques. Students will also have many opportunities to learn about and discuss diverse human rights concerns, and responses, from around the globe.

Requirements & Grading

The grading scheme for this course places greatest value on your reactions to, and engagement with, the course material. We will collaborate to create an open, kind, and curious class dynamic where everyone can comfortably participate. Please contact me as soon as possible if you need particular accommodations, and we will work out the necessary arrangements. Additionally, if you are typically a reluctant class participant, please get in touch so that I can address your concerns and make any helpful adjustments.

The assigned readings include 20-40 pages per week of excerpts from a coursebook, primary sources, and secondary sources. The coursebook (Ilias Bantekas and Lutz Oette, *International Human Rights Law and Practice* (3rd ed. 2020)) is available for purchase online, but the assigned excerpts will be posted on bCourses, along with all other readings.

Participation: 25% of grade. This seminar is intended to be participatory. Participation should always include adequately preparing for class and may also include speaking in class or in group discussions, contributing written comments or ideas, or actively listening and reacting to the discussion. Each class will begin with students' reactions to the readings.

First short paper: 20% of grade. Each student will prepare a 3-page reflection paper (700-800 words) analyzing the text of a human rights treaty or treaty article. What values does it reflect? What obligations does it impose on States or other actors? What kinds of harm does it contemplate, or fail to recognize? Additional assignment details will be provided one month in advance of the deadline of Class 6.

Second short paper: 30% of grade. Each student will prepare a 5-page memo (1,100-1,500 words) proposing and describing a human rights advocacy strategy for a particular violation or pattern of abuses in a specific country. The paper should identify available judicial and non-judicial avenues, and weigh their pros and cons. Additional assignment details will be provided one month in advance of the deadline of Class 12.

Final exam (take-home): 25% of grade. The final exam will be a take-home exam. It will require students to respond to a set of questions with short essay answers. The exam will cover the bigger picture concepts, critiques, issues, and comparisons discussed throughout the course and will require students to demonstrate familiarity with, and understanding of, the various institutions covered in the syllabus.
