**Summary.** The course introduces economics as a tool to analyze the laws that underpin a market economy with an emphasis on property, contract, and tort law. **Learning objective.** To teach students how to use microeconomics to reason about law. **Prerequisites.** No previous knowledge of law or economics is required. **We do not use calculus in this class.**
